Explanation of Responses:

- These shares were granted in the form of Restricted Stock Units ("RSUs"), in connection with the cash dividend paid on September 30, 2022 to stockholders of record as of September 16, 2022 (the "Dividend"), with respect to 1,381 unvested RSUs granted to the reporting person on December 19, 2018, and adjusted for previously declared and paid cash dividends. These RSUs will vest and are payable concurrent with the underlying RSUs.
- These shares were granted in the form of RSUs, in connection with the Dividend, with respect to 866 unvested RSUs granted to the reporting person on August 12, 2019, and adjusted for previously declared and paid cash dividends. These RSUs will vest and are payable concurrent with the underlying RSUs.
- These shares were granted in the form of Performance Share Units (PSUs), in connection with the Dividend, with respect to 806 PSUs granted to the reporting person on August 12, 2019, adjusted for vesting on August 12, 2022, and previously declared and paid cash dividends.
